Direction issued by the Commission	The Commission has received a complaint dated 28.06.2018 from the General Secretary, North East Linguistic & Ethnic Co-ordination Committee, Silchar, Assam alleging violation of human rights of the persons belonging to the minority Hindu community of Bangladesh who left Bangladesh due to religious persecution and came to India. It has been alleged that the victims are put into detention camps in Assam after being declared foreigners by the Foreigners Tribunals in spite of Govt. of India notifications dated 08.09.2015 wherein the religious persecuted minorities of countries like Bangladesh, Pakistan and Afghanistan who took shelter in India till 31.12.2014 are exempted from being prosecuted under Passport Act as well as Foreigners Act 1946. It has been alleged that though the victims are not criminals, they have to live with other convicted criminals in the prisons and are not even paid wages for their work which are normally paid to other jail inmates. The Complainant has submitted a Memorandum demanding that the Govt. of India should immediately pass the Citizenship (Amendment) Bill, 2016 to provide relief to the victims as they would then not be considered as illegal migrants. The Memorandum further elaborately depicts the plight of the victims of the religious minorities of erstwhile East Pakistan/Bangladesh. The Commission has considered the complaint. Let a copy of the complaint along with memorandum be transmitted to (i) Secretary, Ministry of Home Affairs, Govt. of India and (ii) Chief Secretary, Govt. of Assam calling for a report within four weeks.
